## Meeting knowledge and evidence needs

- Research on what works and doesn't catalysing progress towards global goals, frameworks, agreements
- Identify, synthesise, analyse, make sense of data to track progress and boost accountability
- Provide evidence at the intersections of challenges inequalities, environmental sustainability, inclusion
- Co-create knowledge via differentiated research agendas generate pathways to sustainable development

# But we're not always good at learning.....

#### Need to address different expectations for learning and change

- Learning and change a complex, messy relationship
- Not everyone wants to learn
- Change influenced by "rules of the game" (turf, egos, interests, money)

#### Whose knowledge counts?

- Diverse, inclusive, equitable knowledge for transformation
- Evaluation, power and empowerment
- Political, not partisan

## 2. What functions can think tanks play in response to these needs?

- Help navigate uncertain times combine work on urgent needs with longer-term trajectories
- Make case that outcomes from research on complex issues take time, via non-linear processes
- Demonstrate that quality matters and is multi-dimensional
- Connect research to societal needs and challenges
- Make research findings and data accessible, in hands of those who need it
- Acknowledge importance of power and politics

### Through which functions can think tanks make a difference to global challenges?

#### Potential functions of think tanks

- Promote/use open data, facilitating knowledge/evidence sharing through effective communication and education
- Knowledge synthesis demonstrating excellence, rigour, credibility
- Meta-analysis in emerging fields, foresight and scenario work
- Knowledge co-creation via multi-, trans-, inter-disciplinary research
- Doing "research with society":
  - Finding or creating windows of opportunity
  - Engaging different communities and constituencies
  - Participatory and inclusive approaches
  - People owning evidence
  - $\circ~$  Research leading to action and solutions

## 3. How can think tanks help level the global research playing field?

- Global frameworks potential for collective effort but "Northern bias" remains
- Gender and other inequalities still constrain
- Inequities within and between nations free and fair access/opportunity not guaranteed
- "Systemic bias" leaving researchers behind
- Academic "mobility" not equivalent to stronger research systems

### What can think tanks do to address power relations?

- Collaborate on universal challenges
- Be thoughtful and intentional about relationships
- Equitable, trustful, transparent
- Address gender diversity and inclusion
- Adopt environmental responsibility walk the talk
- Connect local and global
- Keep a focus on learning a shared endeavour for mutual benefit

#### Final reflections and ideas

- Global progress on universal agendas inequalities, environmental sustainability, inclusion
- Work at intersections and margins of challenges may hold most promise
- Excellence is currency; engagement generates change
- Politics and power at root of intractable challenges and solutions
- Demonstrate value and use of evidence and research
- Co-create knowledge with those on journeys of transformation
- Promote praxis (reflection in action), be leaders in learning
